INTENDED USE

Comfort Safety Limb Holder is a medical device, which is intended to be use for the immobilization of the limbs, for use in emergency room beds, and anywhere you need a strong and safe subject, avoiding sudden movements. Suitable for restraining the wrists or ankles in patients who present state of agitation.


Equipped with a soft pad with lengthy fastening strips.



COMPOSITION

Interior part: Cotton 100%. Exterior part: velour. Polyurethane foam pad. Ring: Nylon 100%. Through adjustable Velcro closures. Strips of nonwoven polyester 100%.

INSTRUCTIONS FOR USE









- Deploy the immobilizer and place around the patient's wrist or ankle.
- Adjust the immobilizer using the velcro system to the desired diameter.
- Passing the strings by clamping ring.
- Tie the strings at the metallic structure of the bed in such a way that the limb holder remains stretched.

PRODUCT CHARACTERISTICS

Softness and commodity thanks to thicker cushioning. High resistance, allowing blood flow. Breathable, it prevents skin irritation, overheating, moisture and maceration.

PRECAUTIONS AND RECOMMENDATIONS

The use by more than one patient may cause a cross-infection.

Do not use the product on injured skin.

Do not use the product if it is pollutes, dirty or evidently deteriorated.

STORAGE AND SHELF-LIFE
