INTENDED USE

The **Operating Table Cover** is a medical device, which purpose is to provide patients with the greatest of comfort during any operation or surgical procedure. Another use is to absorb the patient's blood or body fluids to clean the operating table or the patient better.

COMPOSITION

Bottom: Polypropylene 100% - waterproof.

Inside Filling: 100% Polyester Wadding synthetic high weight; anti

allergic and antimould.

Upper: Non-woven fabric 100% viscose.

Latex free.



INSTRUCTIONS FOR USE

- Remove the product packaging and deploy the coating.
- Place the cover on the table. Make sure that the impermeable part is below.
- Discard after use.

PRODUCT CHARACTERISTICS

Helps maintain patient comfort during the course of the operation.

Bottom made of waterproof fabric to prevent going through the blood or body fluids to the surgical table. Single use.

PRECAUTIONS AND RECOMMENDATIONS

The use by more than one patient may cause a cross-infection.

Do not use the product on injured skin.

Do not use the product if it is pollutes, dirty or evidently deteriorated.

STORAGE AND SHELF-LIFE

Keep away from sunlight. Keep dry.
