This device is designed for the trunk or abdominal area. Do not use on any other part of the body.

Used to keep a patient in a static position to avoid sudden patient movements during the operation.



COMPOSITION

Internal-external layer: Polyester 100%

Ring: Nylon 100%

INSTRUCTIONS FOR USE

- Unfold the strap over the area of the body and under the table to be held.
- Insert the end of the strap around the bracket and through the buckle.
- Adjust and close with velcro to secure.

PRODUCT CHARACTERISTICS

Breathable material that can be washed easily. Fresh and comfortable.

The length to the diameter of each patient is adjustable by the combination of the velcro system, allowing an effective and effective support. Natural support.

Extra strong straps to increase safety during the surgical process.
