

Foot-Heel Protector

INTENDED USE

Foot-Heel Protector is a medical device indicated to avoid decubitus ulcers in foot and heel on patients who must remain long periods in bed or chair with reduced mobility.

It can also be used as a wound dressing, as it is well placed and fixed, giving great comfort for its easy opening and closing after the cure.

Very effective product to protect the joints because the internal reinforcement spreads and distributes the pressure.



COMPOSITION

Inner/Outer side: Polyester 100%.

Padded with synthetic wadding 100% Polyester, anti-allergic and anti-mold.

Fastening Straps: Polyamide.

INSTRUCTIONS FOR USE

- Remove the protector from its packaging.
- Place the protector at the base of the elbow or heel so that the pressure point matches with the internal reinforcement position.
- Adjust the straps with the velcro system.
