

DISPOMEDIC P SCRUB

SCRUB BRUSH with POVIDONE IODINE antiseptic for healthy skin-biocide for human hygiene

DESCRIPTION:

Brush/Sponge with 7.5% povidone iodine soap suitable for antiseptic cleaning the hands of technical-healthcare personnel. Hand washing in high risk zones. Includes nail cleaner. Hygiene of preoperative patients.

COMPOSITION:

BRUSH: Polyethylene SPONGE: 100% polyurethane foam

ANTISEPTIC: 7,5% povidone iodine soap (0.75% free iodine) 20 ml approx. NAIL CLEANER: Copolymer ABS (acrylonitrile butadiene styrene). Optional

INSTRUCTIONS:

For single use, for antiseptic cleaning of healthy skin. Pre-surgical use.

Wash hands with water, apply antiseptic by brushing for 5 minutes and then rinse and dry with disposable towels or warm air. Causes serious eye irritation. Harmful to aquatic life with long lasting effects. For external use only. Avoid contact with eyes, mucous membranes and sensitive areas of the skin. Possible hypersensitivity to the skin. IF IN EYES: Rinse cautiously with water for several minutes. If you wear contact lenses, remove them if possible. Continue to rinse. Use with caution in children under 2 years of age. Do not use in persons sensitive to its components, nor for a long period of time. It should not be used together with products containing mercury. Do not use in newborns, pregnant women or during breast-feeding. Do not use in people with symptoms of thyroid disease. Keep out of the reach of children. Brush with bristles that hold a soft sponge. Its anatomical design ensures it is more convenient and flexible for the user. The nail cleaner is a thin, green, solid stick, easy to use and with high tensile strength and tear.
