## **GLOWET DISPOCLORH 2%**

### MITTEN with 2% chlorhexidine digluconate for an antiseptic bath

Single-use mitten with aqueous **2% Chlorhexidine** to clean and disinfect healthy, clean and dry skin. Ideal for an antiseptic bath of pre-surgery, bedridden or reduced mobility patients.

#### COMPOSITION

*Mitten*: 60% Polyester - 40% Viscose. 240 x 170 mm  $\pm$  5% *Antiseptic*: 2% Chlorhexidine digluconate (10g chlorhexidine digluconate, 20%), excipients q.s. 100%.

#### HOW TO USE

Gently wipe the area to be treated, leave the product on the skin for at least 1 minute and allow to air dry. The product does not require rinsing. Use a mitten for each body area: chest and neck, left arm and armpit, right arm and armpit, groin and perineum, left leg, right leg, back and buttocks. Discard the mitten after use.



#### WARNINGS

For external use only. Do not swallow. It can cause eye irritation. Do not get in eyes, mucous membranes, sensible or damaged skin areas. IF IN EYES: rinse cautiously with plenty of water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. May cause an allergic skin reaction or skin irritation. Do not use with anionic detergents nor with chlorinated derivatives. Do not use in combination with other products. Do not use on people sensitive to its components, over large body areas or for an extended period. Do not use with non-breathable clothes. Keep out of reach of children. The product can only be used in children under 30 months with medical prescription. The use of alcoholic or aqueous chlorhexidine based products as skin disinfectant has been associated with chemical burns in neonates. IF SWALLOWED: immediately call a POISON CENTER/doctor. If medical advice is needed, have product container or label at hand. Harmful to aquatic life with long lasting effects. To avoid risks to human health and the environment, comply with the instructions for use. Dispose in an appropriate manner and avoid release to the environment. Product efficacy is reduced by an organic burden excess thus a bath or shower is recommended prior to product utilisation. The product is not compatible with soaps, anionic surfactants or chlorinated derivatives. Do not use with hypochlorite whiteners, the combined use of chlorhexidine preparations and hypochlorite whiteners may result in the appearance of brown spots.

#### STORAGE AND SHELF LIFE

Store at temperatures not exceeding 30°C. Keep cool. Protect from sunlight. Shelf life: 2 years.
